- 1. All costs, prices, and/or charges are subject to change without notice.
- 2. Payment in full and in advance for all and or any of our services is a condition precedent.
- 3. Visa fee/payment for accommodation, etc, may be refundable, subject to a penalty, before submission of request to the relevant authority.
- 4. Visa fee/ payment for accommodation etc, is not refundable, once request for such is submitted to the relevant authority, unless denied.
- 5. Cost of Hajj and or Umrah packages or parts thereof e.g. payments for accommodation are not refundable upon commencement of all or any of such activities.
- 6. Upon the procurement of travel documents a client shall only be refunded the cost of his ticket in accordance with the terms and conditions of the issuing airline and or charterers of Aircraft.
- 7. Without prejudice to clause 5 above, in case of cancellation of Hajj or Umrah trip, before commencement of visa and ticketing formalities, a penalty of N25,000.00 (Twenty-Five Thousand Naira only) or a maximum of 5%, whichever is higher, of the total amount is chargeable against the passenger.
- 8. Any or all monetary refunds shall bear bank charges like COT, transfer and/or communication charges, VAT, and /or any other incidental expenses.
- 9. Except where agreed separately and documented accordingly, accommodation in Madina and/or Makkah shall be either in a hotel or in a serviced apartment or a building meant for such purposes, and of a standard approved by the / or a competent authority of the Kingdom of Saudi Arabia.
- 10. Accommodation is on multiple occupancy basis, where average number of beds in a room is 4 depending on the size of the room.
- 11. Except where prior or special arrangement has been made and documented accordingly, a couple travelling together may not enjoy exclusive accommodation.
- 12. Where a client opts to secure an alternative accommodation, he/she forfeits the cost of accommodation included in the agreed package price.
- 13. All or any services and or facilities which a client may be entitled to, provided by the company, and or its agent, shall be available exclusively to the client and to the exclusion of any or all third parties.
